Requirements

1. Conditions of employment:
 - Outstanding artistic and artistic-pedagogical qualifications on historical flutes
 - Intensive involvement with historical performance practice
 - A completed domestic or equivalent foreign university degree appropriate to the position or an equivalent artistic or artistic-academic aptitude
 - International concert activity
 - Extensive teaching experience
 - Regular attendance at the Anton Bruckner Private University and participation in academic self-administration are part of the duty.
 - Special aptitude for academic work, which is usually demonstrated by the quality of a doctorate, and/or special aptitude for artistic or, if applicable, relevant professional activity; for applicants who do not already hold a relevant professorship at a recognized domestic or foreign university, additional special artistic achievements; or special achievements in the application/development of scientific knowledge and methods in at least five years of professional practice; or the presentation of a habilitation. Role & Responsibilities

- Leading a transverse flute class within the framework of artistic education in the bachelor and master studies and teaching of the relevant supplementary subjects, in particular ensemble/consort
- Arts-based research/artistic research and supervision of doctoral students
- In addition to teaching courses, the activities of teaching staff include the necessary preparation and follow-up activities, event and examination activities, research and administrative activities associated with teaching, participation in committees and the supervision and assessment of final theses.
